From the President

It's the start of a new year and spring is in the air at La Buena Vida.

Our Spring newsletter focuses on nature and the habitat that supports it at LBV. There have been several articles in the last few months about residential developments that set aside land to support the plants and animals that live in the local area. The Wall Street Journal in particular had an article stating a greater interest in owning property with such an amenity. LBV has a number of acres set aside devoted to wetlands, a lake and islands that provide many types of flora and fauna for wildlife.

This column outlines my recent bird watching (or birding as we call it) experience on the property. A second article explains the abundant fishing opportunities available as described by one of our resident successful fishing couples, Bruce and Dorinda Ellingsworth.

On Dec. 27, 2015, I participated in the national Christmas Bird Count and spent 90 minutes covering the south end of Lake La Buena Vida, identifying as many birds as possible. Sixteen different species totaling 89 individual birds were observed and recorded for the count. No doubt, you have seen the many Great Blue Herons and Great White Egrets that frequent the islands and shallow waters, and may venture on your property. Both Great Blues and Great Whites were seen that day, but also two less familiar heron species, a Tri-colored Heron (photo 1 below) and the smaller, but similar, Little Blue Heron (photo 2 below).

Several other less common species appeared also. Two resident raptor species hunt our property regularly. An Osprey (see photo at left) hovered above the lake and ate his catch on the Shallow Water signs in the lake.



A beautiful American Kestrel (see photo at left) hunted the grass on several lots, perching on signs and lamp posts spotting prey.

Also logged that day, a number of different birds helping themselves to our lake fish such as Double-crested and Neotropic Cormorants, Brown Pelicans, and Pied-billed Grebes, as well as a saucy Belted Kingfisher (final photo).

A flock of 100+ Redhead Ducks occupied the Lake that day, much to the chagrin of property owner Mike Scharck, a long-time avid duck hunter.

You don't have to take a walk to see colorful hummingbirds in your own yard. Attracting them is as easy as putting out a feeder or two or landscaping with native flowering plants. Their antics provide constant entertainment around our patio and pool for Bob and me as well as for visitors not used to seeing them up close.

I welcome all of you to take a few minutes for a short bird walk around LBV and look for the many different species you can find here. You might be surprised at what you see.

Redfish are more plentiful, with several in the 26" – 28" range, but Bruce did snag a 30 incher, and has the picture to prove it!

Watering Restrictions

Stage 2 Restrictions continue for La Buena Vida, and anyone that gets water from the City of Rockport. The reservoirs that provide our potable water have risen, but they are still not high enough to change our Stage 2 water restrictions. Please make your best effort to conserve your personal water use, both inside and outside your home. Restrictions include the following:

- Watering limited to once a week between the hours of 6 pm and 10 am
- Citations will be issued for anyone that does not adhere to the schedule
- Customers with questions are encouraged to contact the Public Works Department of the City of Rockport at (361)790-1160.
- The watering schedule for Stage 2 is:
 - Even numbered residence TUESDAY
 - Odd numbered residences WEDNESDAY
 - Commercial (including the POA) THURSDAY

Most of the information in the Handbook is available on the website, except financial statements that we do not make available to the public.

The Bylaws of the Association govern the election of the Board of Directors of the Association, their term of office, and meetings, powers and duties. Each owner of a lot in the La Buena Vida subdivision is automatically a Member of the Association, with one vote per lot. Members elect all Directors for a term of one year.
