- 2. <u>Section 2.10</u>. Section 2.10 of the Declaration is amended to add the following:

In addition, no sign shall be displayed in a Common Areas without the prior written approval of the Board.

3. Section 6.3. Section 6.3 of the Declaration is amended to change "\$1,000" to "\$2,000."




